### Synopsis

My area of expertise is memory in legal settings. I lead an ERC-funded team of postdocs, PhD students and research assistants researching eyewitness testimony in cross-cultural settings. I am co-founder and director of the Amsterdam Laboratory for Legal Psychology (ALLP) at VU Amsterdam. I regularly appear as an expert witness in criminal cases, mentor colleagues in writing expert witness reports, and serve on advisory committees of the Netherlands Register of Court Experts and the Dutch National Police. My teaching includes the *Psychology* course in the international *Law in Society* programme and *Project Reasonable Doubt*, in which potentially dubious criminal convictions are re-evaluated.
